- Free bus service for girls between the girl's hostel and faridipur campus (for the hostel inmates only) is available. All other users will have to pay @ Rs. 300/per month or Rs. 1750/- per sem or Rs. 3000/- per academic year in advance.

AICTE directives on ragging are given below for guidance of students. PREVENTION AND PROHIBITION OF RAGGING IN TECHNICAL INSTITUTIONS AICTE VIDE ITS F.NO. 37-3/legal/AICTE/2009 dated 25.03.2009 has notified REGULATIONS 2009 for prevention an Prohibition of Ragging in Technical Institutions.

Various Types of Ragging: The Raghavan committee Constituted by the Hon'ble Supreme Court has, inter-alia, mentioned the following types of ragging-

- Regging has several aspect with among others, psychological, social, political, economic, cultural and academic dimensions.
- 2. Any act that prevents, disrupts or disturbs the regular academic activity of a student should be considered within the academics related aspect of ragging, similarly, exploiting the services of a junior student for completing the academic tasks assigned to an individual or a group of seniors is also an aspect of academics related ragging prevalent in many institutions, particularly in the technical Institutions.
- Any act of forencial extortion or forced expenditure hurden put on junior students should be considered as ragging of
 economic dimensions.
- 4. Any act of physical abuse including all variants of its: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to the health or person can be put in the category of ragging with criminal dimensions.
- 5. Any act or abuse by spoken words, e-mail, snail-mail, blogs, public insults should be considered withing the psychological aspects of ragging. This aspect would also include deriving perverted pleasure, vicarious or sadistic thrill form actively of passively participating in the discomfiture to others; preparing "Preshers" in the run up to their admission to higher education and life in hostel also can be ascribed as a psychological aspect of ragging-coping skills in interaction with seniors or strangers can be imparted by parents as well, any act that effects the mental health and self-confidence of students also can be described in terms of the psychological aspects of ragging.
- The political aspect of ragging is apparent from the fact that incidents of ragging are low in institutions, which promote democratic participation in governance and decision making within the institute bodies.
- 7. The human rights perspective of ragging involves the injury caused to the fundamental right of human dignity through humiliation heaped on the junior students by seniors; often resulting in the extreme step of skicide by the victims.

Action to be taken against students for including and abetting in Ragging in technical institutions, Universities including Deemed to be University imparting technical education -

- 1. The punishment to be meted out to the persons indulging in ragging has to be exemplary and justified harsh to act as deterrent against recurrence of such incidents. The students who are found to be undulged in ragging should be debarred from taking admission in any technical institution in India.
- In every single incident of ragging a First Information Report (FIR) must be filed without exception by the Institutional authorities with the local police authorities.
- 3. Depending upon the nature and gravity of offence as established by the Anti-ragging Committee of the Institution the possible punishments for those found guilty of ragging at the institution level shall be any once or any combination of the following-
- 1) Cancellation of Admission.
- ii) Suspension from attending classes.
- iii) Withholding/withdrawing scholarship/fellowoship ans other benefits.

- Debarring form representing the institution in any regional national or international meet, tournament, Youth Festival etc.
- v) withholding Results.
- vi) Deburring form representing the institution in any regional, national or international meet, tournament, Youth Festival
- vii) Suspension/expulsion form the Hostels.
- viii) Rustication from the Institution for period ranging from 1 to 4 semesters.
- ix) Expulsion form the institution and consequent debarring from admission to any other institution.
- x) Fine of Rupees 25,000/-
- xi) Collective punishment: when the person committing or abetting the crime of ragging are not identified, the Institution shall resorts to collective punishment as a deterrent to ensure community pressure on the potential raggers.
- 4. The Institutional authority shall intimate the incidents of ragging occurred in their premises along with action taken to the council and immediately after occurrence of such incident and inform the status of the case time to time.



Co-Curricular Activities
